**ADDITIONAL INFORMATION ON THE PROCESSING OF PERSONAL DATA FOR THE SHAREHOLDERS OF «PLAISIO COMPUTERS S.A»****A. PROVISION OF INFORMATION TO DATA SUBJECTS**

The Societe Anonyme under the brand name «PLAISIO COMPUTERS S.A» (hereinafter referred to as «PLAISIO»), in addition to informing the shareholders about the processing of personal data, it informs the shareholders that for reasons of their participation in the remote annual Ordinary General Meeting of PLAISIO (hereinafter "General Meeting"), will be collected and processed by the executor of processing "Hellenic Central Securities Depository SA", which has been assigned by PLAISIO, the organization of the remote General Meeting of Shareholders, the passwords on the online platform [www.athexgroup.gr/AXIAeShareholdersMeeting](http://www.athexgroup.gr/AXIAeShareholdersMeeting), through which they will participate and vote remotely in the General Assembly (hereinafter "Internet Platform").

Also, PLAISIO informs the shareholders that, according to par. 2 of article 131 of law 4548/2018, the remote voting is obvious and the exercise of the right to vote by the shareholder and the content of his vote, if requested, may be notified to the other shareholders participating in the General Meeting.

In addition, PLAISIO informs, as responsible for processing, in accordance with Regulation (EU) 2016/679 of the European Parliament and of the Council (GCP), Law 4624/2019 and other provisions on the protection of personal data, natural persons besides the shareholders, who will participate in the teleconferencing (video conference) of the remote General Meeting, such as the Company's executives, Board Members, Auditors and other third parties, that it processes their following data, which are collected directly by the individuals for the purposes of legitimate interests pursued by PLAISIO for this processing:

- (a) identification data, such as name, patronymic, ID card or other equivalent document,
- (b) data on the capacity under which such persons are entitled to participate in the General Meeting,
- (c) e-mail address for the purpose of the natural person's participation in the teleconference,
- (d) video-audio data from the participation of the natural person in the General Meeting.

Recipients of this data are the executives of PLAISIO responsible for the management of the General Assembly, the Societe Anonyme "Hellenic Central Securities Depository SA", which has been assigned by PLAISIO, as the executor of the processing, the organization of the remote General Assembly as well as any executors of the Societe Anonyme "Hellenic Central Securities Depository SA" [such as e.g. Cisco Hellas S.A. which provides the WEBEX tool /

services team with the ability to provide video conferencing via cloud services which is maintained within the European Economic Area].

Personal data is kept by PLAISIO for the period required by law or in accordance with the legal basis for the observance of the data, based on the purpose of their processing, as well as for the time required by each applicable legal and / or regulatory framework or for the exercise of claims or the defense of the legal interests of PLAISIO.

According to the GDPR, the individuals have the following rights, which may be exercised on a case-by-case basis:

- (a) to know what personal data concerning them are kept and processed by the Company, as well as their origin (right of access),
- (b) to request the correction and / or supplementation thereof, so that it is complete and accurate, providing any necessary document from which the need for completion or correction arises (right of correction),
- (c) to request the restriction of the processing of their data (right of restriction),
- (d) to refuse and / or oppose any further processing of their personal data held by PLAISIO (right of objection),
- (e) to request the deletion of their data from PLAISIO's files (right of deletion),
- (f) to request PLAISIO to transfer the data provided to it to any other controller (right to the portability of the data).

For the exercise of the above rights, the natural person may address PLAISIO

PLAISIO will make every effort to respond to the natural person within thirty (30) days from the submission of his request, which may be extended for sixty (60) additional days, if required at the discretion of PLAISIO, taking into account the complexity of the request and the number of requests. PLAISIO will inform the natural person in any case of extension of the period of thirty (30) days within thirty (30) days from the receipt of the request and will also inform him of the reasons for the extension.

PLAISIO S.A implements an information security management system to ensure confidentiality, security of data processing of natural persons and their protection from accidental or unlawful destruction, loss, alteration, prohibited dissemination or access, and any other form of unauthorized processing. The natural person has the right to file a complaint with the Personal Data Protection Authority ([www.dpa.gr](http://www.dpa.gr)), which is the

competent supervisory authority for the protection of the fundamental rights and freedoms of natural persons, against the processing of data concerning him, if he considers that his rights are being infringed in any way, as well as the right to a judicial appeal.
